## **NOTICE INVITING TENDER**

Online E-Tender is invited by the **Principal, Government Girls' General Degree College** from reputed, registered and professional Security Personnel supply having at least three years' experience in providing such services related to Housekeeping, Private Security Guards for the FY 2023-24 of this College. It is also required from registered professional agencies to provide experienced Security personnel for the College for the FY 2023-24. Interested parties may follow the instructions as given below for submission of their tender in online mode. Price should be quoted in INR currency inclusive of all taxes.

### 1. General Instructions:

In the event of E- Tendering, intending bidder may download the tender documents from the website: <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate (DSC).

### 2. Submission of Bids:

Both technical Bid and Financial Bid are to be submitted concurrently duly digitally signed by the Company personnel who is in the pay roll of the Company (having Authorization from the Company management) in the website <http://wbtenders.gov.in> All the papers must be submitted in English language.

### 3. The eligibility criteria are given below:

- I. Submit the quotations stating that wages to be paid to the personnel in terms of current Labour Departments' minimum wages rates and other statutory deductions also to be provided them as per State Government notification. (Wages per day per head, Contribution for ESI, EPF, and Bonus etc. per day per head, Service Charges per day per head, these rates also be given per month per head as well as per annum per head.)
- II. The rates should remain valid for the period up to March 2024 after considering Labour Departments' minimum wages rate.
- III. The tender should be submitted in the proforma enclosed herewith.
- IV. The violation of any of the conditions will entitle cancellation of the order.
- V. Scan copy of from of Income tax return for the last three financial year, GST Registration certificate, PAN No. Current Trade License, current license of Home & Hill affairs Departments, Govt. of West Bengal, P. Tax other related licenses and registration certificates, if any, and also credentials.
- VI. The tender inviting authority shall verify the above-mentioned documents (In original) which are mandatory for the participation before issuance of the work order.
- VII. The prospective tenderers as a primary agency should have satisfactorily completed the supply to any Government or Private Organizations for the last three (03) years.
- VIII. The tenderers are to deposit the tender papers for the individual items.
- IX. Payment of the bills on its production will be made after successful completion of requisite services within reasonable time.
- X. The tender bid will be out rightly rejected if it comes to the notice of the tender inviting authority during scrutiny that the credential or any other paper of a tenderer is fabricated etc.
- XI. The undersigned reserves the right of accepting or cancelling the tender without assigning any reason.
- XII. To qualify for a Package of contracts made up of this and contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for individual contracts.
- XIII. No bidder could charge "Zero Price" as Service Charge, if so then the bidder concern will not be considered as a valid participation in the concerned Tender process.
- XIV. No bidder could charge "**Zero Price" as Service Charge**. This is because this tendering process/exercise is meant for 'Hiring of Service', so the agency **quoting 'Zero Service Charge' will not be considered as a valid participant in the concerned Tender process.**
- XV. **In case two or more technically qualified firms quote the same lowest price, i.e. more than one L1, then, the firm with superior credentials in the technical bid shall be awarded the contract. as per Finance order No: 2320-F(y) Dated:07/06/2022.**

4. Payment of 2% of total quoted rate as Earnest Money Deposit (EMD) will be through Online payment Mode either through NEFT / RTGS or Net Banking as per Finance order No. 3975f(y) Dated: 28-07-2016.

A security deposit of 3% of the total amount bid to be deposited by the L1 bidder, which includes 2% as Earnest Money Deposit. And 15 security deposit will also be adjusted from the final bill of the L1 bidder.

L1 bidder has to submit 2% as Earnest Money of the quoted piece. All agencies have to deposit Initial amount of Rs. 10000/- (Online) during online bidding, excess amount will be deducted from L1 bidders final bill after calculating L1 price in the tender.
